

Compliance Burden

The scrap recycling industry continues to bear most of the weight of scrap theft compliance.

A report from the National Insurance Crime Bureau (NICB), headquartered in Des Plaines, III., found that scrap theft has increased by 80 percent in recent years. Between 2009 and 2011, the NICB identified more than 25,000 insurance

claims related to metals theft, an increase of 81 percent compared with claims made between 2006 and 2008. read more...
